#### Arthouse – Disclosure Statements – Fiscal 2017:

In order to meet the highest standards of Ontario charitable law, the CRA and Imagine Canada, Arthouse amended its By-laws in Fiscal 2016 with respect to full disclosure of any payments made to Board Members for products and services to those board members or companies in which a board member is an owner, partner or senior manager, and secondly, Arthouse is providing compensation details at least at the same level as that required by CRA in the T3010 Information Return.

#### Amended and Approved At Special Meeting of the Board – Held January 20-2016 – Clause 10:

“No Arthouse Board Member is entitled to receive, either directly or indirectly, any salary, wages, fees, commissions or other amount for services rendered to the organization in their capacity as a director of the Corporation.”

#### Staff Compensation – For Fiscal Year ended June 30-2016:

The Arthouse Executive Director and the Program Director operated as “independent contractors” to the organization. And while compensation disclosure is not required by CRA’s T3010 Schedule 3 (Compensation), Arthouse provides full disclosure regarding compensation for these two positions at least at the same level as that required by CRA in the T3010:

1. Enter the **number** of permanent, full-time, compensated positions in the fiscal period = 2
2. For the **ten (10)** highest compensated, permanent, full-time positions enter the **number of positions** that are within each of the following annual compensation categories:
  - \$40,000 – \$79,999 – 3 Contracted Employees
3. Total expenditure on all compensation in the fiscal period = \$107,979 (not including HST)
